Netherlands India Business Meet

On the 22nd of October, the NIBM got launched for the first time in a digital format. More than 250 participants registered for the three hours program on the theme 'Operating in the New Normal: Changed Future of Business & Policy for The Netherlands-India Business Corridor'. The moderation was done by Vidhya Sampath (Director Corporate Affairs Europe – Tata Consultancy Services and VP Programs & Liaison to the Advisory Board).

After the welcome and opening remarks of Mrs. Edith Nordmann (Chairman NICCT and Managing Partner ACG International), more than 150 people got addressed during the keynote session. Mona Keijzer (State Secretary for Economic Affairs & Climate Policy), H.E. Mr. Venu Rajamony (Ambassador of India to The Netherlands), H.E. Mr. Marten van den Berg (Ambassador of The Netherlands to India) gave their thoughts on how business, government and political leaders in their professional capacities as well as individuals view the new normal and our future. 
The keynote session was followed by a Policy Session, a video address by Sohang Sengupta (Founder ZeroDollarSecurity) and a Business Session.

The theme of the policy session was "Shaping the New Normal: How government policy and regulation will be redefined post-Covid India-NL business". Jacco Vonhof President of the Royal Dutch Association of Small and Medium-Sized Enterprises (MKB-Nederland), Maria van der Heijden (Director MVO Nederland), Harbeen Arora (Founder and Global Chairman – Women Economic Forum (WEF) and Women's Indian Chamber of Commerce and Industry (WICCI)) provided their thoughts, experiences and advise.

The theme of the business session was "Shaping our new normal: Learnings from the business world". Victor Everhardt (Deputy Mayor of Amsterdam), Professor Dr. P.V. Aravind (University Groningen & Lead Negative Emission Program TU Delft), Peeyush Kaushik (Head of Healthcare Innovation Centre & Business Leader – Philips) and Paul Schuilwerve (CEO & Country Head India – Rabobank) focused in this session on the practical learnings from the last few months. They shared best cases and best practices which can be applied going forward into our new normal. A vivid discussion was presented on new opportunities, and how businesses can take learnings forward to build more resilient companies/organizations to better serve the IN-NL business corridor.

Throughout the whole session, participants could write their questions in the chatbox which were then asked by the moderator. This ensured that participants were envolved in the programme. Polls were conducted in order to understand the views of participants.

NICCT in association with HCL Technologies and The Hague Security Delta organized on the 12th of November 2020 the Online Debate on "Where does Cybersecurity go from here?"

The COVID-19 pandemic, and the resulting dispersion of large parts of the workforce, has high-lighted the growing digital interconnectedness of the world while also underscoring the threat that this poses for enterprises and their customers. 

From 8 until 15th of February 2021, The Netherlands organized a virtual economic mission to India with the presence of the Dutch Prime Minister for Foreign Trade and Development, Mrs. Sigrid Kaag. Mrs. Ingrid Thijssen, president of the Confederation of Dutch Industry and Employers (VNO-NCW) lead the Dutch business delegation. The Economic Mission was organized by RVO together with the Ministry of Foreign Affairs, Embassy of India to The Netherlands, Embassy of The Netherlands to India and NLin-Business.

Organizations from the Netherlands (including the Dutch Caribbean islands) and India, active in the sectors "food", "energy", "water" gained understanding of the local challenges, gained market information and expanded their network with new business contacts. Throughout the week webinars about interesting developments and projects in NL and India were organized, as well as match making sessions and tailor made matchmaking appointments.

During the Economic Mission, NICCT organized and moderated a round table session for Dutch entrepreneurs wanting to do business in India. Approximately 25 participants participated enthusiastically in the round table. The session was moderated by Jelke Schippers (Managing Director Smartshore and board member NICCT). Marijke van Liemt (Manager International Business), Rasoul D. Mikkelsen (Director Strategic Business Development – Royal Eijkelkamp) and former ambassador of The Netherlands to India Mr. Eric Niehe addressed the participants and gave the participants a beautiful insight in their achievements within the Indo-Dutch business corridor.

In total 325 Indian and 116 Dutch participants joined the economic mission. Most of the participants originate from start-up, MSME, industry, university, R&D Institutions.





Private Public Partnership on Opportunities for Sustainable Farming in India

When: 28 February 2021

Where: Online

In co-operation with: Foundation Critical Choices India

On Sunday 28 February 2021, Foundation Critical Choices India in co-operation with NICCT organized a webinar "Private Public Partnership on Opportunities for Sustainable Farming in India" from 14.00-16.00 hrs.

Farming is a primary source of livelihood for about 58% of India's population. Indian agriculture is multifaceted and accounts for around 16% of the GDP. Despite this, Indian agriculture sector faces several challenges, such as low effective yield, underinvestment in Agri-infrastructure, fragmented land holding, lack of technical skills, lack of crop diversification, poor storage capacity etc. As a result, economic contribution of agriculture to India's GDP is steadily declining; still this sector is playing a significant role in the overall socio-economic fabric of India. The core of this is the Indian farmer, whose income is way below the national average. Certainly, Indian agriculture sector needs to witness paradigm shift from labour intensive (low-tech) to knowledge intensive (high-tech) sector. Therefore, huge investments and active involvement of young-educated work force are required. The objectives of this webinar were to discuss:

- 1) Possibility of introducing PPP (public private partnerships) in the agriculture sector to pump much-needed resources in this sector.
- 2) How India can focus on crop diversification and still ensure stable income for the farmers.
- 3) Other important issues such as ensuring minimum income for farmers, building storage capacity, and role of digital technologies (including smart phone) in information sharing about the weather and market situation etc.

Approximately 100 participants joined the online session.



"With Coronavirus taking a toll on the global economic activities, Finance Minsters' and tax administrators have faced a tough task to undertake a balancing act between rolling out incentives / tax deferrals and maintaining fiscal discipline. The Hon'ble Indian Finance Minister presented the Indian Union Budget, 2021, and foreign investors and domestic players alike are keen to understand the measures to provide impetus to one of the fastest recovering economy during the pandemic. Outside of the Union Budget, there have been several developments in the last 12 months which impact / are beneficial for the foreign investors".

To provide an overview of the macro-economic landscape and help shed some light on the Budget proposals, NICCT and EY invited the members and non-members of NICCT to a virtual event where the developments on the Indian Budget 2021 were discussed. All speakers shared their expertise with the participants and answered all questions during the interactive Q&A.






Doing business / Investing in India
