3. Programs

From June 2022 until September 2023 NICCT organized various programs (on its own and in partnership) to promote business relations within the Indo-Dutch business corridor.

During Covid-times NICCT hosted online programs which can be divided into three categories:

1. NICCT Online – Debate in where a small panel of speakers address a topic significant to the NICCT Community.

2. NICCT Online – Conversations with Leaders in which a one-to-one conversation takes place with captains of industry and prominent leaders in the Indo-Dutch business corridor.

3. NICCT Online – Digital Drinks where members can network with each other in an informal setting. Often this program component is combined with a Master Mind Quiz.

Halfway the year 2022, the government of The Netherlands uplifted all the COVID-restrictions. This enabled NICCT to host more physical events, which were partly hosted in a hybrid form.

The opening session was followed by a conversation on the impact on large and small scale companies, prognosis and key changes required and the role of technology. Indian economy has shown great resilience during the pandemic and continues with record GDP growth making it one of most attractive destinations for foreign direct investment. At 6% growth, as per EY report, India economy will likely be over US\$ 26 trillion by 2047-48.

Technology led adoption to new ways of working & flexibility has become the cornerstone of work. Powered by technology, the world, including B20 countries are entering a new era, defined by changing ways of working and how we enable skilling, reskilling/upskilling. Thus, there is a need for B20 countries to adopt a skill ontology driven approach, and build a standardized skill framework. Furthermore, it is equally critical to create heat map of economic activities across geographies, enabling targeted approach to build skilling capacities and skilling on a mission mode.

"Given the scope, nature and demand for skills in emerging industries, it is important to create a cross border digital skill platform for formal and informal workforces at a global level", highlighted Mr. Vikramjit Singh Sahney, Member of Parliament, Rajya Sabha and Founder and Chairman, Sun Foundation, India at the session "Future of Work: Building Resilient & Sustainable workforce" of the CII Partnership Summit 2023, today in New Delhi. He added, that the future of work is expected to disrupt the current skill training ecosystems and we have to be proactive about it, align our skill training and work closely with public-private partnerships.

FCCI International Conference on UN Reforms for the Changing World Order

On the 3rd of May 2023, FCCI organised the conference on the above mentioned topic. The background to it was the following:

The United Nations (UN) is a 77 year-old world organisation representing 193 Member States. In today's highly multi-polar, and globalized world, the UN is facing critical issues and several new global challenges are emerging (especially in relation to peace & security) that require co-ordinated actions. Thus, incremental structural reforms at both UN and UNSC levels are vital for building consensus amongst the member states to make these institutions more relevant and effective.

The main aim of this international conference is to present the findings of a systematic study conducted by FCCI, exchange views, and openly discuss much-needed UN reforms with the representatives of several UN member states, representatives from veto-holding nations, G-4, G-20, C-10 nations, EU, and other stakeholders.

The conference program was highly interactive and included speakers and panelists from different backgrounds, such as experts on UN affairs, diplomats, representatives from the corporate world and experts on international laws. At least 15 ambassadors from across the globe (representing major continents) confirmed their participation to this conference.

NICCT (Edith Nordmann – Chairman) was invited to take a seat in the panel together with H.E. Mrs. Reenat Sandhu (ambassador of India to The Netherlands) and others, to give her view on the paper and her ideas on how to reform.







Round Table Doing Business in India

30 Participants registered for the program. During the program the participants were able the share their experiences in doing business in India. The round table enabled all to exchange their knowledge and widen their network. In the end an informal networking took place.





B20 Summit India 2023

When:25-27 August 2023Where:New DelhiInitiated by:CII, joined by NICCT

India officially assumed the G20 Presidency on 01 December 2022 after taking over from Indonesia. As the official G20 dialogue forum for the global business community, B20, during India's Presidency, led the process of galvanizing global business leaders for their views on issues of global economic and trade governance and speak in a single voice for the entire G20 business community.

Throughout India's G20 Presidency, the B20 India Secretariat, represented by the Confederation of Indian Industry (CII), led the B20's activities. Under the guidance of Mr N Chandrasekaran, Chair, B20 India and Executive Chairman, Tata Sons, the Secretariat was responsible for overseeing the development and execution of the B20 process.

In the same vein as its forerunners, B20 India brought together enterprises of all sizes, from all sectors, segments, and regions to provide constructive ideas to global governments towards promoting a thriving, resilient, sustainable, digitised, innovative and inclusive business paradigm under its over-arching theme of R.A.I.S.E (Responsible, Accelerated, Innovative, Sustainable, and Equitable Businesses).

To set the foundation for formulating actionable recommendations, the Secretariat operated through seven Task Forces and two Action Councils to transform the vision of global businesses into implementable policy recommendations for the G20 leader's consideration. The outcomes from each Taskforce and Action Council under B20 India were formulated after rounds of consultations with the members of B20 India, International Advocacy Caucus, Government, and other stakeholders.

With the G20 Presidency proceeding towards its completion, the B20 India Secretariat hosted the B20 Summit during 25-27 August 2023 at Hotel Taj Palace, New Delhi. The Summit witnessed plenary sessions on the priorities identified during B20 India.

NICCT joined the B20 Summit India 2023. NICCT' chairman, Mrs. Edith Nordmann, participated actively as a speaker in the B20 meetings throughout the year as well as this meeting.

In the period from Sunday afternoon, September 10th, to Thursday, September 14th, 2023, an important economic mission to India took place, spearheaded by Prime Minister Rutte and Ingrid Thijssen, the Chair of VNO-NCW and the leader of the mission. The mission commenced in Bangalore, where all the participants gathered before branching out into two distinct groups: Key Enabling Technologies and Medical Technology, which headed to Hyderabad, and Sustainable Food Systems, which embarked on their journey to Mumbai (Pune).

The opening part of the program, held on Sunday and Monday, was strategically designed to provide ample opportunities for networking. It featured a trade mission reception, a formal dinner, networking events, and informative seminars, allowing participants to engage and connect with one another.

On Monday, September 11th, NICCT (Netherlands India Chamber of Commerce & Trade) had the honor of inaugurating NICCT India.

This significant event was graced by the presence of Prime Minister Rutte, who performed the actual launch of NICCT, the Dutch Ambassador to India, Mrs. Marisa Gerards, and the Dutch Consul General to Bangalore, Mr. Ewout de Wit and attended by four board members of NICCT India as well as supportive companies and individuals who played a crucial role in the establishment of NICCT India.

5. Financial Statement NICCT

The financial position of NICCT remains stable. We also welcomed Broekman as our new patron member. The COVID-situation is no more of a past now as we organised a number of in-person events in 2022.

2022 has been the year where buisnesses are evolving from the pandamic and so is the India-Nederlands corridor. As in earlier years we see reduction in NICCT memberships due to costs cutting by most businesses, non-payment of fees by members due to struggling financially to make ends meet. Others have re-evaluated their strategies and decided to discontinue their business practices in India which resulted in resignation from NICCT membership. However the total new members who joined NICCT in 2022 are 13.

We regret to see the members leave but understand their choices. NICCT's efforts to enhance long term especially as it has initiated its plans to open an office in India and NICCT believes to attract new members going forward as it steps into India.
